- 4. I have read and understood all Cook Islands Maritime Legislation relevant to the maritime document I am applying for.
- 5. I authorise Maritime Cook Islands (MCI) to collect and receive from any person, organisation, or government department any information relevant to:
  - a. my knowledge of and compliance with transport safety regulatory requirements;
  - b. my physical or mental health or any serious behavioural issues;

- c. any criminal investigations, charges, or convictions, including matters relating to transport safety offences;
- d. any regulatory actions, including suspension, revocation, or refusal to issue a licence or certificate of competency.
- 6. I consent to the collection, processing, and storage of my personal data by Maritime Cook Islands in accordance with applicable data protection laws, including the General Data Protection Regulation (GDPR), solely for the purposes of processing this application and for maintaining regulatory records.
- 7. I authorise the person or company named in section 2 to act on my behalf in all matters relating to my Cook Islands certification, including the submission of this Fit and Proper Person form and related documents.
- 8. I declare that MCI will be advised of any changes to the details supplied above as soon as practicable by myself or my representative.
- I acknowledge that under MCI STCW Rules, section 11.4, MCI has the authority to cancel or suspend a Certificate of Competency (CoC), Certificate of Proficiency (CoP), Certificate of Endorsement (CoE) or Seaman's Discharge Book.
